3. James Walton [co-founder, co-creator](#) and Executive Director of Great Work Inc. (2014 990 [GW990](#))
4. Great Work Inc's trade name is Great Work Montessori (SOS [ID 20161062892](#))
5. Great Work Inc states "Our current thinking is to apply for a public charter, unapologetically asking for waivers from all constraints that are in direct conflict with our pedagogy." (archived website [greatworkinc.org](#) - 3/14/2015)
6. Great Work Inc states "Great Work is eager to have an impact on the debate about the goals of public education. We are "growing" our school from one Young Child's Community and one Primary class opening in January 2016. At the same time we will be gathering support and preparing our petition for Jefferson County Charter approval." (archived website [greatworkmontessori.org](#) - 9/24/2015)
7. Great Work Inc. appears to have created Great Work Montessori Learning Community Inc. (GWMLC), Great Work Montessori Lab School (trade name for GWMLC), and Great Work Montessori School (GWMS - proposed charter school) - (Colorado Secretary of State - same incorporator, addresses, etc.)
8. Great Work Inc.,GWMLC, Lab School (trade name for GWMLC - SOS [ID 20161219030](#)), and GWMS (charter school) all currently share the same principal address 6001 W 16th Ave Lakewood CO 80214 (Colorado Secretary of State)
9. Great Work Inc.,GWMLC, Lab School (trade name for GWMLC), and GWMS (charter school) are all Incorporated by Paul A. Svoboda (Colorado Secretary of State)
10. GWMLC, Lab School (trade name for GWMLC), and GWMS (charter school) all share the same Executive Director and Registered Agent - Amy Malik (Colorado Secretary of State & [greatworkmontessori.org](#))
11. Great Work Inc. Registered Agent - Brian Peter Sense (Colorado Secretary of State)
12. Executive Director Great Work - Brian Peter Sense ([greatworkmontessori.org](#))

13. The Executive Director of Great Work Inc. was charged with starting the charter school, and is intended to supervise its principal (<http://www.topschooljobs.org/jobs/131896-139138/Executive-Director-Great-Work-Inc--Denver-CO-USA>) .
14. The Great Work Inc. and Great Work Education Holdings Inc. Articles of Incorporation are virtually identical (with the exception that GWEH Inc. is missing 1-6 of their Articles of Incorporation Colorado Secretary of State)
15. Great Work Education Holdings Inc. listed its address with City of Lakewood as 6001 W. 16th Ave, the same principal address as proposed Great Work Montessori School charter applicant, and other Great Work entities (https://webcache.googleusercontent.com/search?q=cache:H_N3jRcvxfcJ:https://www.lakewood.org/Documents/Finance/Taxes_and_Public_Improvement_Fees/New_Business_List_Archive.aspx+&cd=1&hl=en&ct=clnk&gl=us)
16. Great Work Inc. and Great Work Education Holdings Inc. principal addresses changed one day apart (GW 6/1/2015 & GWEH 6/2/2015)to share the 1112 Washington Ave. suite 200 Golden CO 80401 address (Colorado Secretary of State - NOTE: This is the same address at which “TGNA Inc.” supposedly resides)
17. Great Work Inc. and Great Work Education Holdings Inc. share the same Board (2014 990’s [GW990](#) & [GWEH990](#))
18. Great Work Inc. and Great Work Education Holdings Inc. have most of their Board Directors employed by Walton Enterprises LLC (2014 990 [GW990](#) & [GWEH990](#))
19. TGNA Holdings LLC (NOT a non-profit) owns the land at Center Ave & Sheridan that Great Work Montessori School (charter school) intends to lease (Jeffco Clerk & Recorder/Assessor)
20. TGNA Holdings LLC also owns the property at 6001 W 16th Ave Lakewood CO 80214 (Colorado Secretary of State - NOTE: This is the current principal address for Great Work Inc., GWMLC, Lab School and GWMS)
21. TGNA Holdings LLC has direct ties to the Walton Family Foundation (Colorado Secretary of State)
22. William (Bill) Bethke has been identified as the outside legal counsel for the potential Great Work Montessori Charter School (This is the same attorney who claims that there is no right for the public to ask questions of charter school governance).

23. The website "greatworkinc.org" forwards to greatworkmontessori.org
24. The separate facebook websites for Great Work Inc. (@greatworkinc) and Great Work Montessori Learning Community (@greatworkmontessori) both list the same physical address (6001 W. 16th) and website (greatworkmontessori.org)
25. Greatworkmontessori.org is registered to Amy Malick, using the email address amymalik@greatworkinc.org. You read it correctly, Ms. Malick's email address is a Great Work Inc address - the company that is supposed to have no official ties with the proposed charter school.
